


Ordinance 2022- 11

AN ORDINANCE AMENDING TITLE 1 CHAPTER 7 OF THE CITY OF WOODLAND HILLS CITY CODE

WHEREAS the Woodland Hills City Council (“Council”) set forth and clarify the indemnification of employees, and elected and appointed officials of Woodland Hills City

WHEREAS the Council desires to protect the City of Woodland Hill’s employees, elected officials, appointed officials, and city authorized volunteers in the case of litigation when acting within the scope of their duties to the City of Woodland Hills;

WHEREAS the Council wants its employees, elected officials, appointed officials, and city authorized volunteers to be able to work for the City of Woodland Hills to the best of their abilities without fear of representing themselves in litigation;

WHEREAS the Council finds that passage of this ordinance is in the best interest of the health, safety, and welfare of the citizens of City of Woodland Hills and will protect its employees, elected officials, appointed officials, and city authorized volunteers.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Woodland Hills City, Utah, as follows:

1. Title 1 Administration Chapter 7 Officers and Employees of the City of Woodland Hills Code is hereby amended by the addition of the new Section 1-7-7:

1-7-7 INDEMNIFICATION OF CITY EMPLOYEES AND ELECTED AND APPOINTED OFFICIALS

It is the intent of the City to indemnify its employees, elected officials, appointed officials, and city authorized volunteers of to the fullest extent consistent with Governmental Immunity Act of Utah, Title 63G, Chapter 7 of the Utah Code Annotated. The City shall defend and indemnify employees, elected officials, appointed officials, and city authorized volunteers from claims which may arise while acting in the scope of their duties for the City except for the following:

A. Fraud or willful misconduct of the City’s employee, elected official, appointed official, and city authorized volunteer;

B. Operation or control of a vehicle by the City’s employee, elected official, appointed official, and city authorized volunteer while under the influence of drugs or alcohol; or

C. Physical or mental impairment resulting in the City's employee, elected official, appointed official, and city authorized volunteer being unable to reasonably perform his/her job functions because of the use of alcohol or non-prescribed drugs.

2. This Ordinance shall be effective April 13th 2022
