AN ORDINANCE AMENDING CITY CODE TITLE 10-6-4(B) Appeals-Time Limit for Filing

WHEREAS, the City of Woodland Hills City Council held a public meeting on May 25, 2021 at 6:00pm, for the purpose of amending Title 10-6-4 Appeals: Time Limit for Filing, and;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOODLAND HILLS, UTAH City Code 10-6-4(B) Time Limit for Filing be ADOPTED to read:

An applicant, or any other person or entity, may appeal to the appeal authority for relief within fourteen (14) days of an order, requirement, decision or determination by the planning commission, building inspector or zoning enforcement officer.
