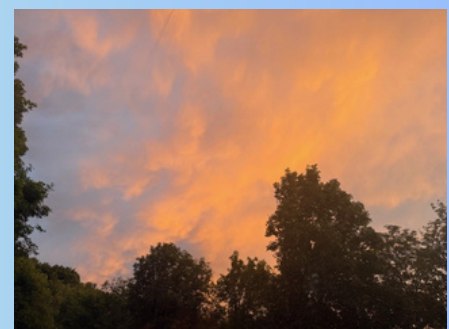

### TED TALK -FIRE SAFETY

With summer weather upon us, it's a good time to think about fire safety in our community. Woodland Hills City is designated as a Wildland Urban Interface Community (WUI). A WUI is a zone where human development meets or intermingles with undeveloped wildland or vegetative fuels. In previous articles, I've discussed fuel reduction and mitigation. This article will focus more on fire safety. Woodland Hills City municipal code 5.4 addresses some of the wildland interface/fire safety requirements we adhere to as a WUI community. For example, all new construction in our city is required to install a fire sprinkler system in the home. The goal of this requirement is to keep a fire contained within the structure and prevent it from spreading to the community. Roof coverings are required to be of non-combustible materials, and vents have to be screened. These safety requirements apply to new construction to protect our community. There are also fire safety ordinances that apply to all residents and non-residents. Fireworks of any kind are not permitted in our city. This includes all fireworks, sparklers, worms, pop-its (snaps), etc. Our code also prohibits any open fire within the city. The exceptions to this ordinance include stoves and fire pits fueled solely by liquid fuel with a 10-foot clearance, charcoal fire grills, barbeques, and smokers are permitted as long as they can be completely covered. If you see any fireworks being used or, non liquid fueled open flames, please call 911. There are also a few things you can do in the event of a house fire to protect your family and the community. For example, if a fire starts inside the house, close all the doors if you have time and do not break windows unless it's for life safety. Fire requires three essential elements to grow, which are fuel, heat, and oxygen. Closing doors and windows helps starve the fire of oxygen and slows its growth. This is also a good practice when going to bed at night. If you close the interior doors for each room, a fire will spread much more slowly and possibly stay contained to one room, providing more time for a safe escape. Lastly, if you are located near a city fire hydrant, please help us keep it clear. Clear is defined as removing any vegetation over 4 inches in height or removing snow to less than 8 inches in depth within 3 feet of the hydrant, not parking vehicles or equipment in front of the hydrant, or any other items that could block it. Fast access to the fire hydrant can help save a structure, a life, and the community.

Woodland Hills operates under a Mayor-Council form of government with five council members and no city manager. In this structure:

- The Mayor serves as the chief executive officer, overseeing city operations, presiding at meetings, executing ordinances, and representing the city at the local and regional level.
- The City Council functions as the legislative branch, enacting ordinances, adopting budgets, and working directly with residents to address community concerns and priorities.

Without a city manager, both the Mayor and City Council members assume additional responsibilities, requiring them to work closely with staff, committees, and residents to ensure the effective and transparent operation of city government.

Council members should be open to learning about municipal code, state code, budgeting, and public infrastructure. They must listen to diverse viewpoints and make decisions that align with the community's long-term best interests.

## **A Rewarding Way to Serve**

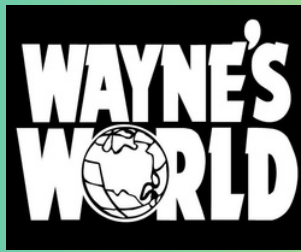

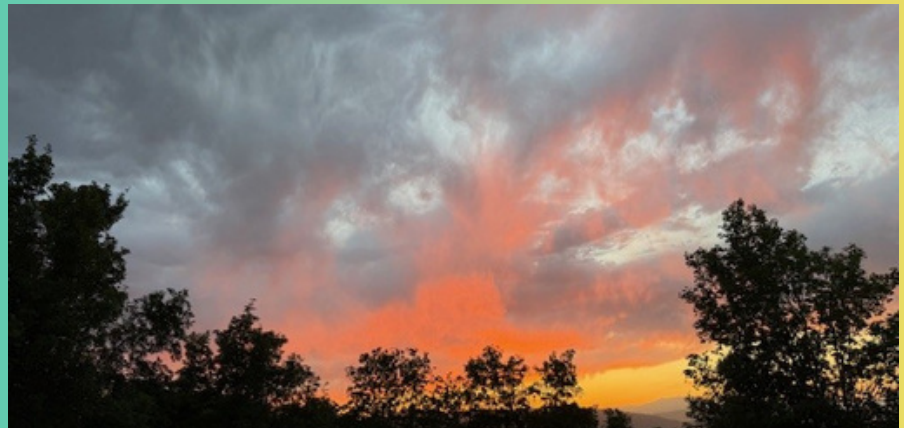

THAT IS ENTIRELY THEIR RIGHT IN DOING SO. PLEASE RESPECT ONE AND ANOTHER'S PROPERTY AS YOU WOULD LIKE OTHERS TO RESPECT YOURS. THIS IS PRIMARILY A PROPERTY OWNER TO PROPERTY OWNERS MATTER TO RESOLVE BUT IF THE MATTER IS SERIOUS ENOUGH LAW ENFORCEMENT CAN BECOME INVOLVED. ALL HAVE A GREAT SUMMER. MANY THANKS TO THE FIRE MITIGATION EFFORTS OF EVERYONE AND THE CHIPPING CREWS FOR ALL THE WORK DONE.
