

Ordinance. 2022- 21

**AN ORDINANCE CREATING A FEE SCHEDULE FOR MISDEMEANOR VIOLATIONS OF THE CITY OF WOODLAND HILLS CITY CODE TO BE INCLUDED AS PART OF THE CITY FEE SCHEDULE**

**WHEREAS**, the City of Woodland Hills has authority pursuant to Utah Code Ann. Section 10-3-703 to impose a criminal penalty for the violation of any municipal ordinance by a fine not to exceed the maximum fine for a class B misdemeanor fine under Utah Code Ann. Section 76-3-301; and

**WHEREAS**, it is in the best interest of the City to have an official schedule of fees for misdemeanor violations included in the city fee schedule.


