

## Ordinance 2026-01

### AN ORDINANCE ADOPTING A CHANGE OF ZONE CLASSIFICATION FOR CERTAIN PROPERTY LOCATED IN THE CITY OF WOODLAND HILLS.

WHEREAS the proposed zone change has been referred to the Woodland Hills Planning and Zoning Commission for consideration in accordance with Utah Code Annotated §10-9a-501 et seq. (1953 as amended);

WHEREAS, the Planning Commission for Woodland Hills has recommended to the Woodland Hills City Council to adopt the proposed change in zoning; and


WHEREAS a public hearing was held before the Woodland Hills City Council on January 6, 2026, where public input was received.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Woodland Hills:




## CERTIFICATE OF POSTING ORDINANCE
