## RESOLUTION NO. 2021-12

### A RESOLUTION CERTIFYING THE CANVASS OF THE 2021 City of WOODLAND HILLS MUNICIPAL GENERAL ELECTION

WHEREAS, pursuant to Utah Code Ann. § 20A-4-3014(2)(a), the Mayor and the Municipal Legislative Body constitutes the Board of Canvassers of the City of Woodland Hills;

WHEREAS, on November 16, 2021, the Board met to canvass the election returns of the 2021 City of Woodland Hills Municipal General Election held on November 2, 2021;

WHEREAS the election returns have been received and counted by the Utah County Clerk's Office; And

WHEREAS the Board publicly canvassed the returns and determined from the vote for each candidate;

NOW, THEREFORE, be it resolved by the City of Woodland Hills Council, acting as the Board of Canvassers, as follows:

#### 1. Approval of Election Results.

The City Recorder is authorized and directed to:

1. Record and file the certified report in a book kept for that purpose;
2. Prepare and transmit a certificate of nomination or election under the officer's seal to each elected candidate;
3. Publish in a newspaper of general circulation in the Board's jurisdiction, on the Utah Public Notice Website, and on the City website, a copy of the certified report or a statement that the Board of Canvassers for City of Woodland Hills has prepared a report of the election results for the 2021 Municipal General Election and specify the sources where an individual may view or obtain a copy of the entire certified report; and
4. File a copy of the certified report with the Lieutenant Governor.

**Effective Date.**

This Resolution is effective immediately upon passage.


