## **2013 PUBLIC OFFICE ELECTIONS**

Notice of Municipal Offices to be voted on in the Woodland Hills City Municipal General Election on November 5, 2013:

Candidate Filing Period Begins June 3, 2013.

Declaration of Candidacy Forms or Nomination Petition must be filed in person with the City Recorder at 690 S Woodland Hills Drive, Utah between the hours of 9 a.m. and 12 p.m.

Candidate Filing Deadline Ends June 17, 2013 UCA 10-3-301.

- The City uses a telephone-based emergency alert system to contact residents if there are any pressing public safety issues of immediate concern. Please provide the City Recorder with telephone numbers where you and your family members can be reached in case of an emergency. You can list as many telephone numbers as you like. - *The City is looking for individuals or teams to serve as Woodland Hills Day Chair, 1st Vice Chair, and 2nd Vice Chair. These volunteers will receive full support and necessary assistance from previous organizers of the event. This will also allow continuity from year to year as the 1st Vice Chair will assume leadership next year followed by the 2nd Vice Chair in two years.*
- Woodland Hills Day is scheduled for September 14, 2013.
- The City Council is working on changes to the City Accessory Building Ordinance. It will mean any accessory building under 200 square feet needs to meet some minimum requirements but won't require a building permit.
- A temporary salt storage facility has been constructed and there has already been noticeable improvement in loading and spreading.
- The City is still exploring high-speed Internet options.
- The City has approved the preliminary plat for a new 80-acre development in the southwest part of the City.
- The City is still looking at different options for creating a 55 and older community zone.
- Leslie Dicou has been appointed to serve on the South Utah Valley Animal Shelter Board.
- The City Council approved the upgrade to the lighting at the Community Center.

## **DEPUTY NOTICE**

During a snowstorm please pay attention to the sign at the bottom of the hill. If it says 4 wheel drive or chains required and the light on top of the sign is flashing please obey the restriction. This will prevent vehicles becoming stuck on the roadway and blocking the roadway from being plowed. Violations of the restriction may result in citations. It is much safer for all travelers to leave 2 wheel drive vehicles in the Church Parking lot. The church as requested if you have to leave a vehicle, please park on the far north end of the parking lot and do not leave the vehicle for more than a day or two.
